5) ICRA 2022 Wrap Up (V. Kumar and G. Pappas)

- 7,876 registered, 4,703 in person, 96 exhibitors
- 64% are first time ICRA Attendees
- 3,287 papers reviewed, 1,498 presented
- Total Revenue \$3,447,496 - Estimated Surplus \$807,048
